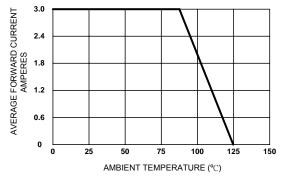


Figure 1. Forward Current Derating Curve

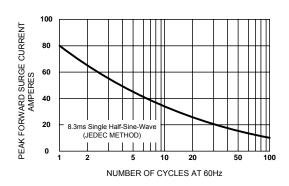
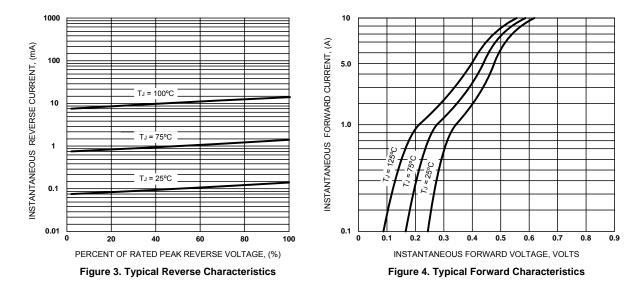


Figure 2. Maximum Non-repetitive Surge Current



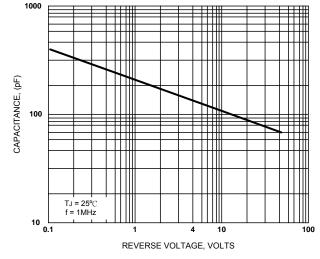
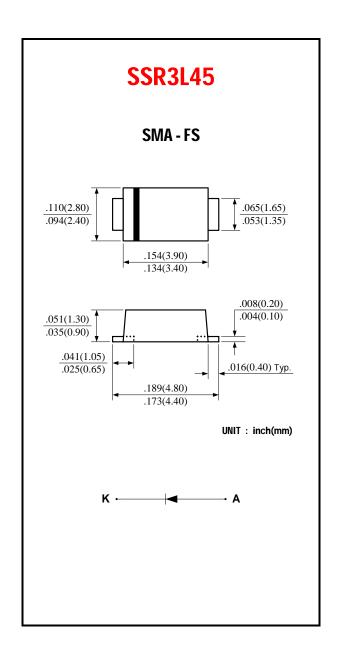


Figure 5. Typical Junction Capacitance
